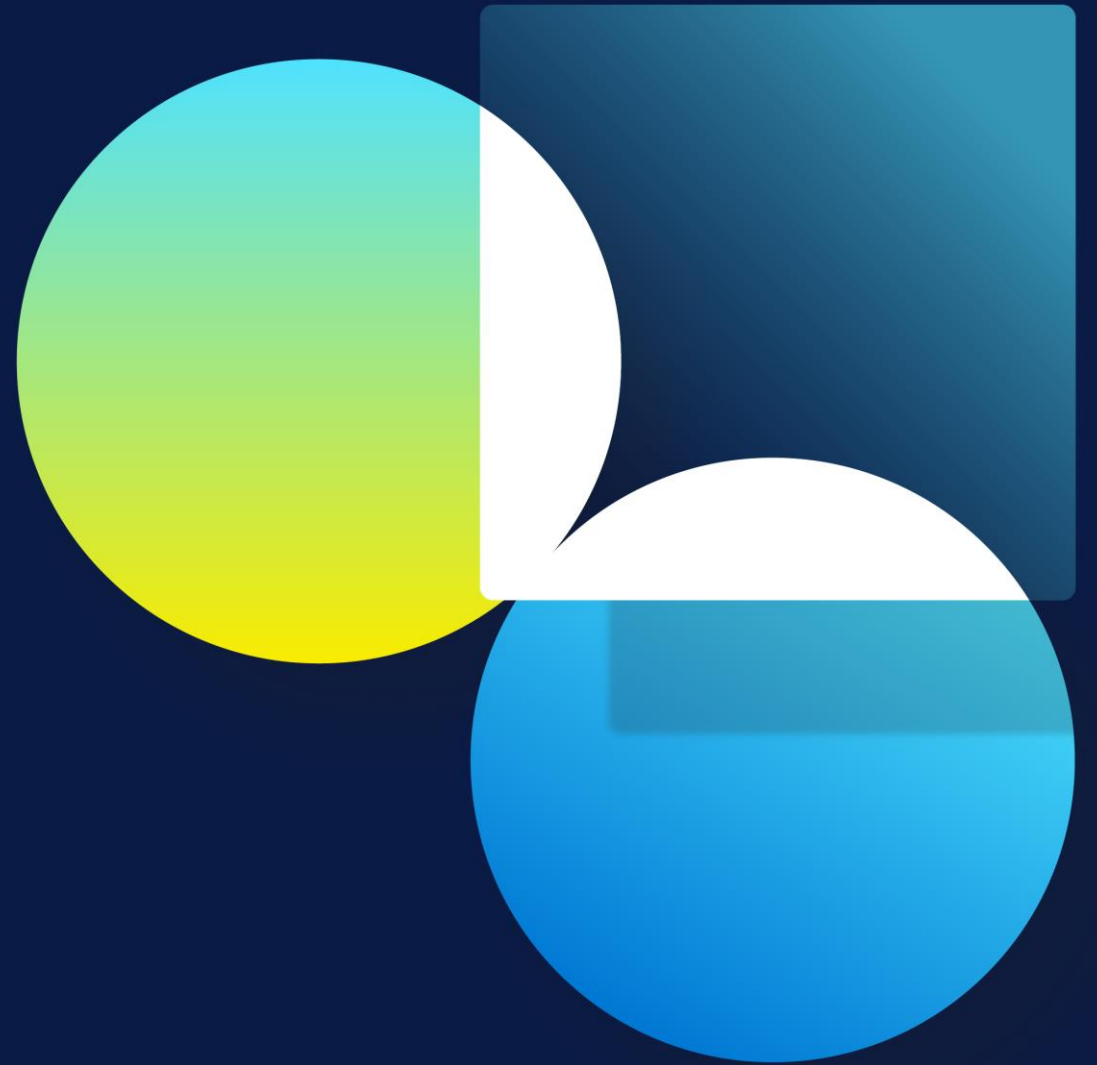

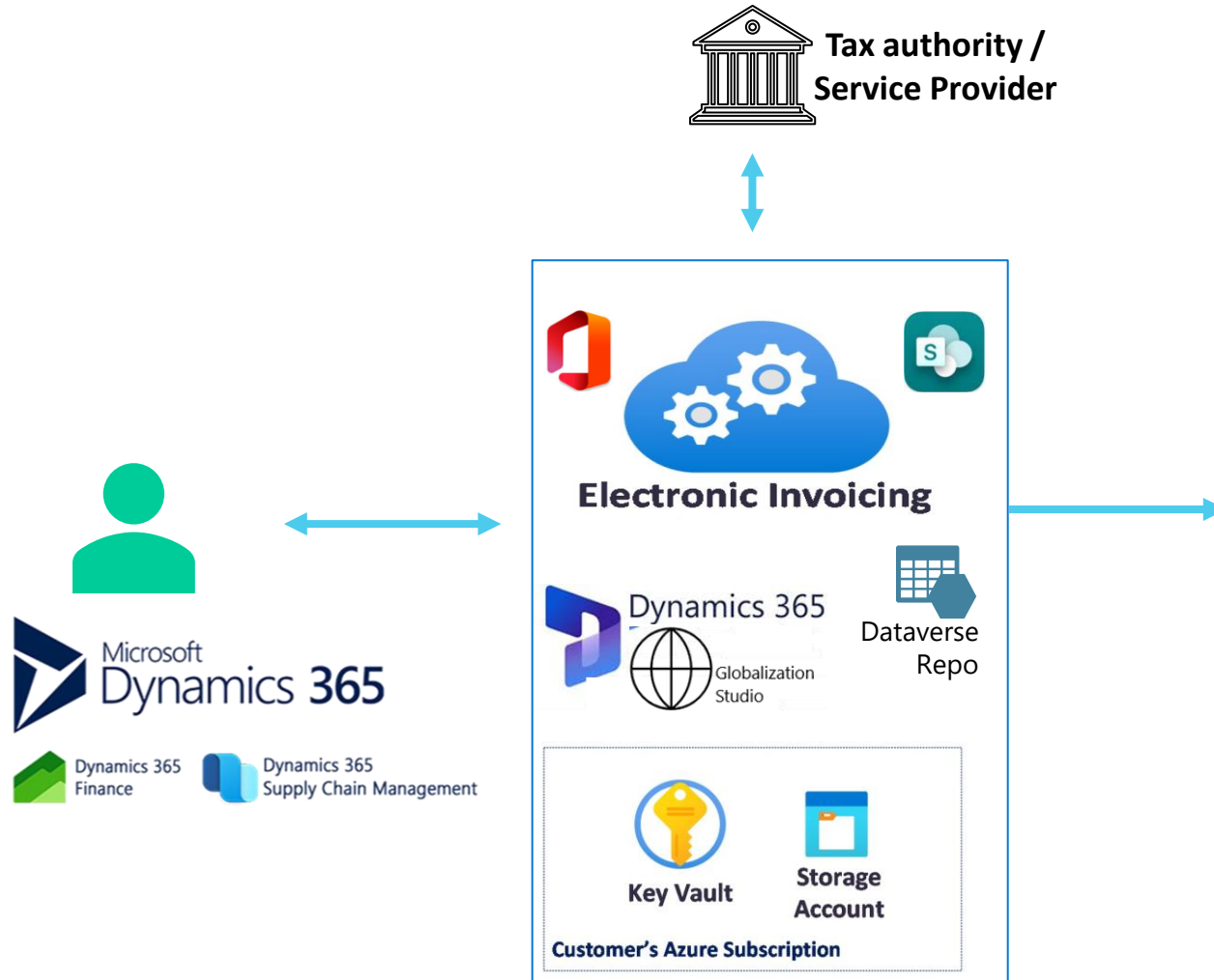

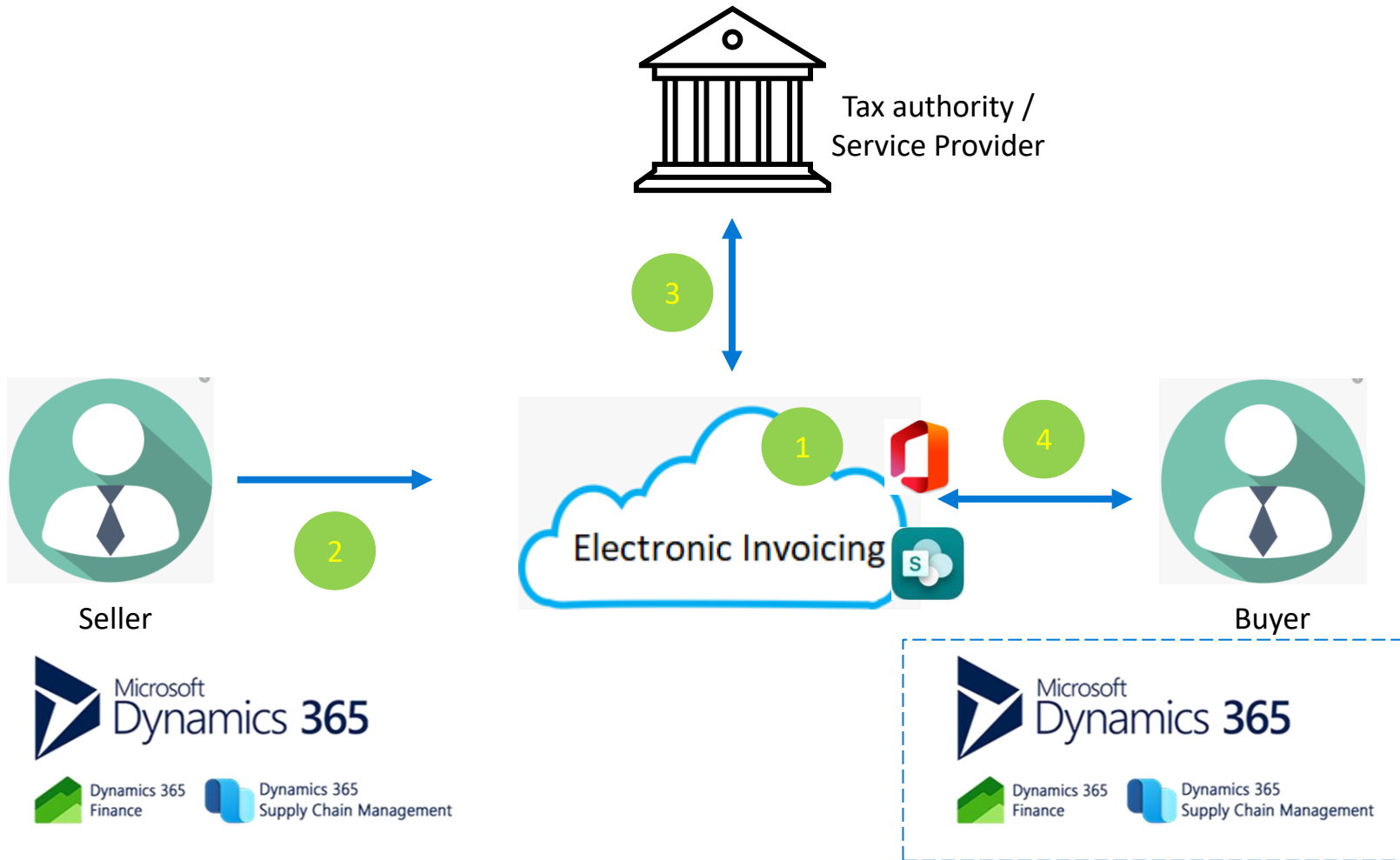


# Electronic Invoicing Service Overview



- Hyper-scalable multitenant service
- Fully-Configurable processing of e-invoices & electronic document exchange
- Configuration of the service through the setup of Globalization features in the Globalization Studio workspace
- Based on Electronic reporting
- Configurable formats & mappings are easily adaptable
- Digital signatures
- Direct integration with tax agencies
- ISV last-mile connector with EDICOM
- Electronic invoicing service doesn't support on-premises deployments.

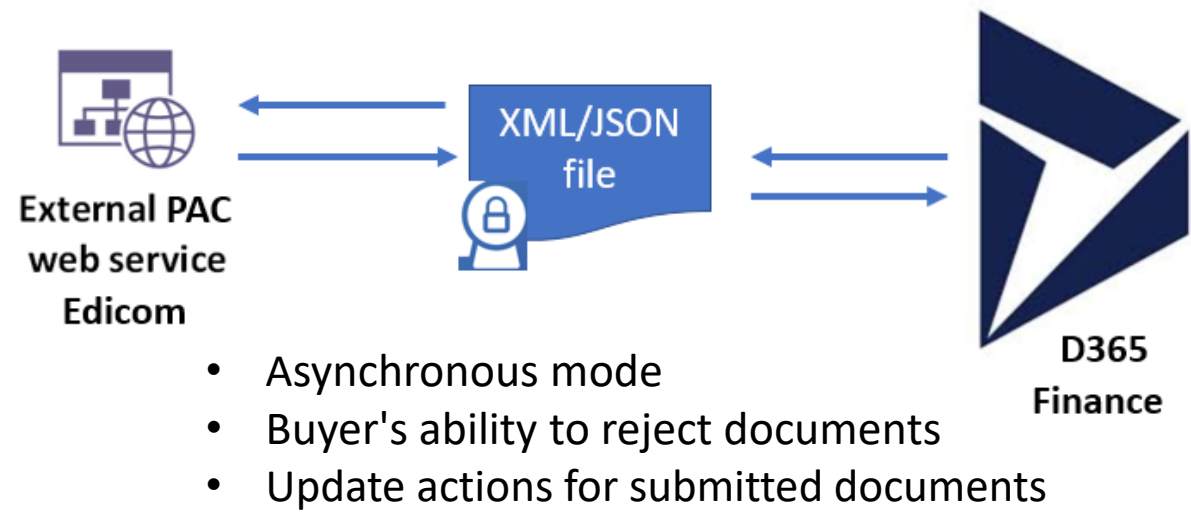
# Electronic Invoicing Service Capabilities



- 1 Formats** invoice data into locally regulated e-invoice formats based on structured business data.
- 2 Signs** e-invoice with digital certificates per country rules.
- 3 Submits** e-invoice to Tax authority's web services for processing and approval. **Logs** all events and responses.
- 4 Receives** e-invoices in multiple formats and saves them in the Finance database. Integrates with MS 365 and SharePoint to automatically receive e-invoices.



# E-Invoicing Service for Chile



## Outbound flow for sales

1. Generate XML document
2. Submit to Edicom
3. Get signed document from Edicom
4. Get invoice status from Edicom
5. Process invoice status response
6. Terminate due to buyers acknowledgement / rejection or after 8 days

## Inbound flow for purchases

1. Receive a vendor invoice
2. Perform syntactical validation
3. Send acknowledgement response to the vendor
4. Send a rejection to the vendor

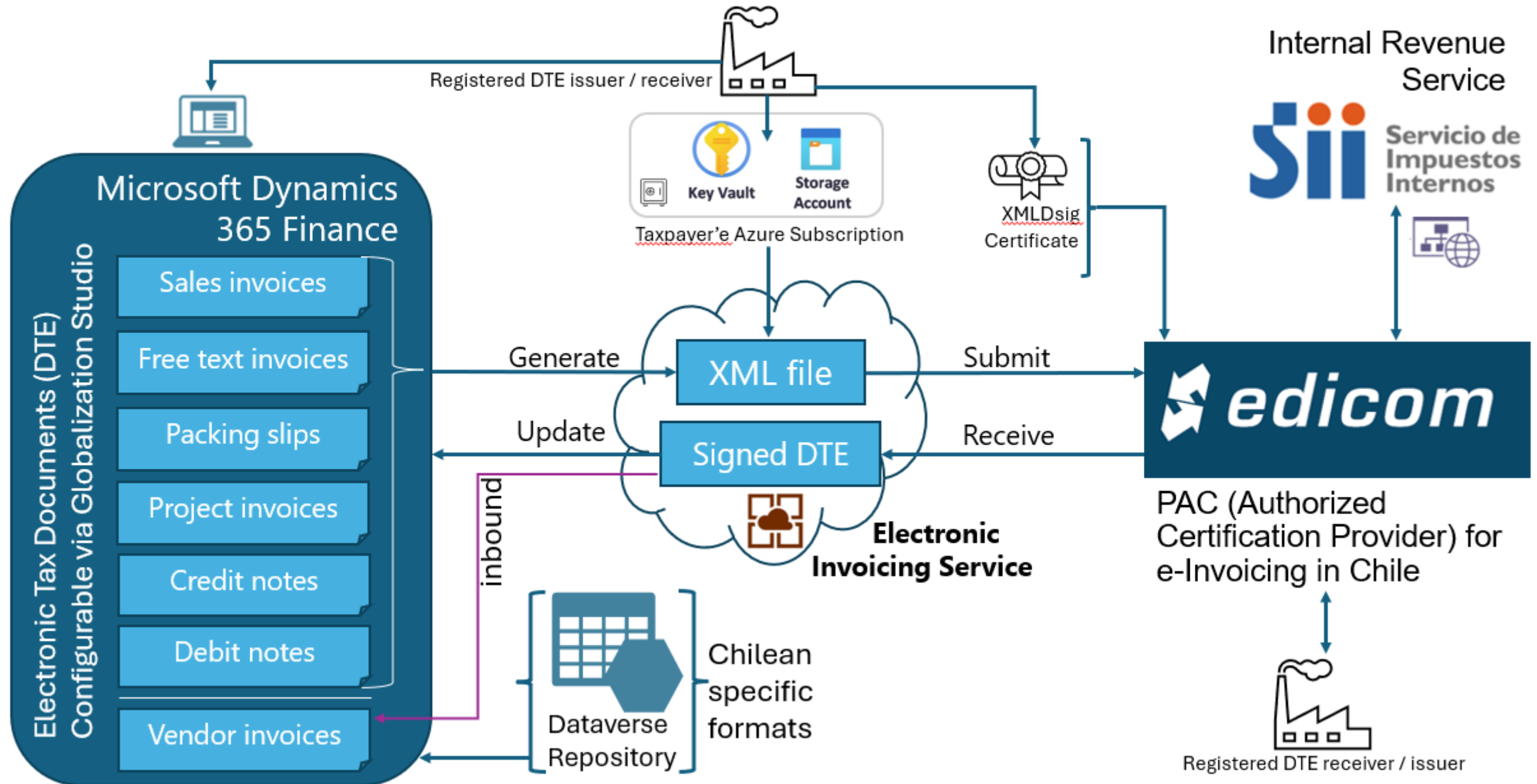

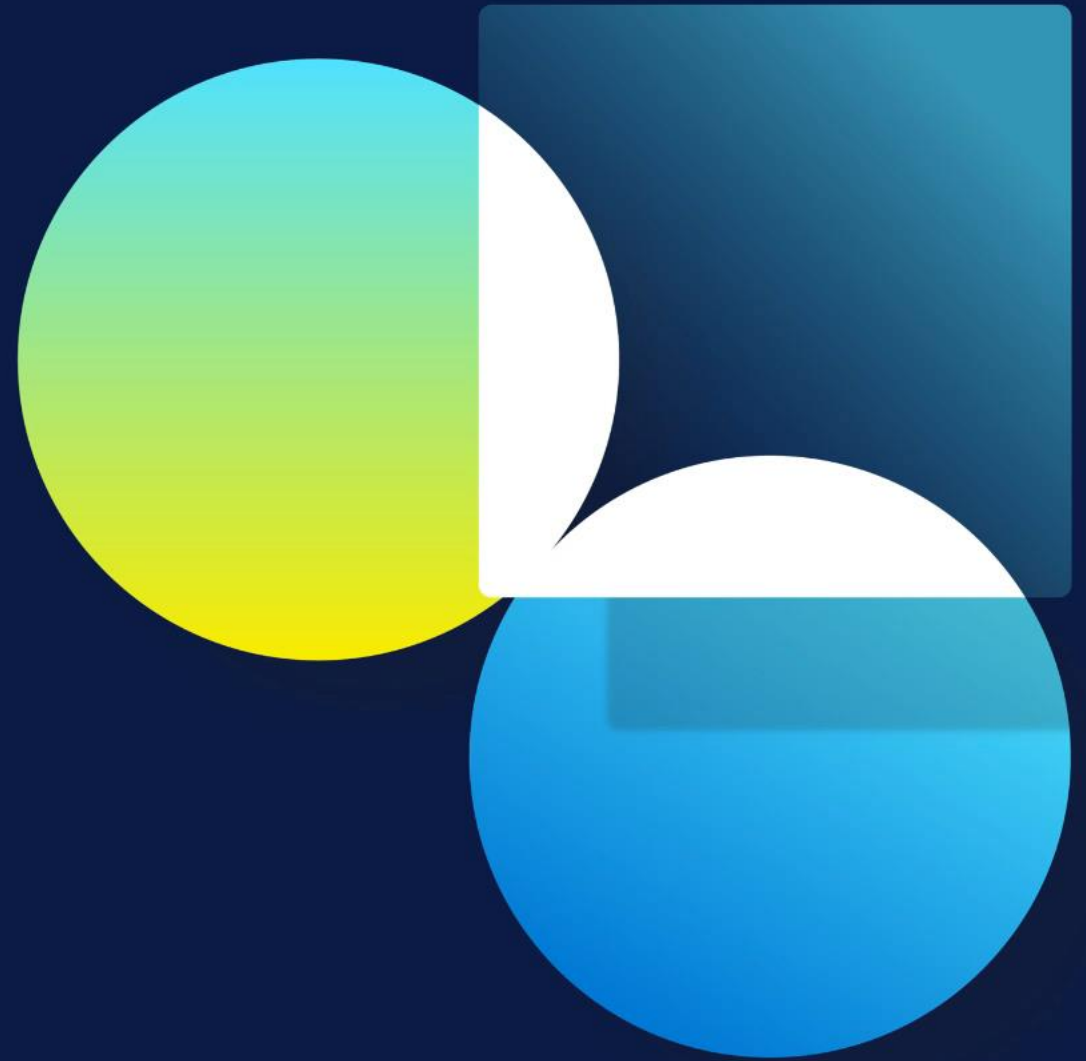


# E-Invoicing for Chile: last-mile connector with Edicom

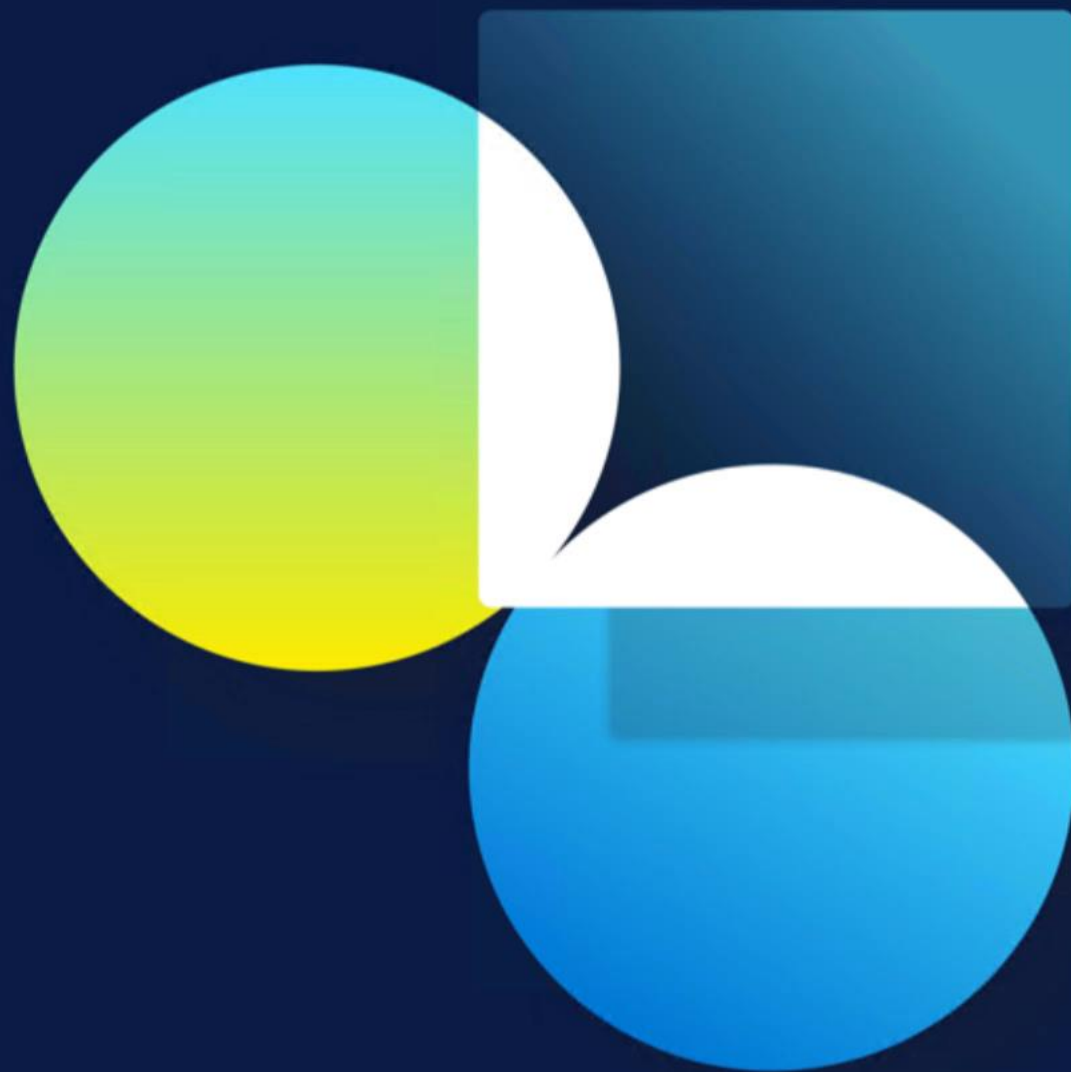

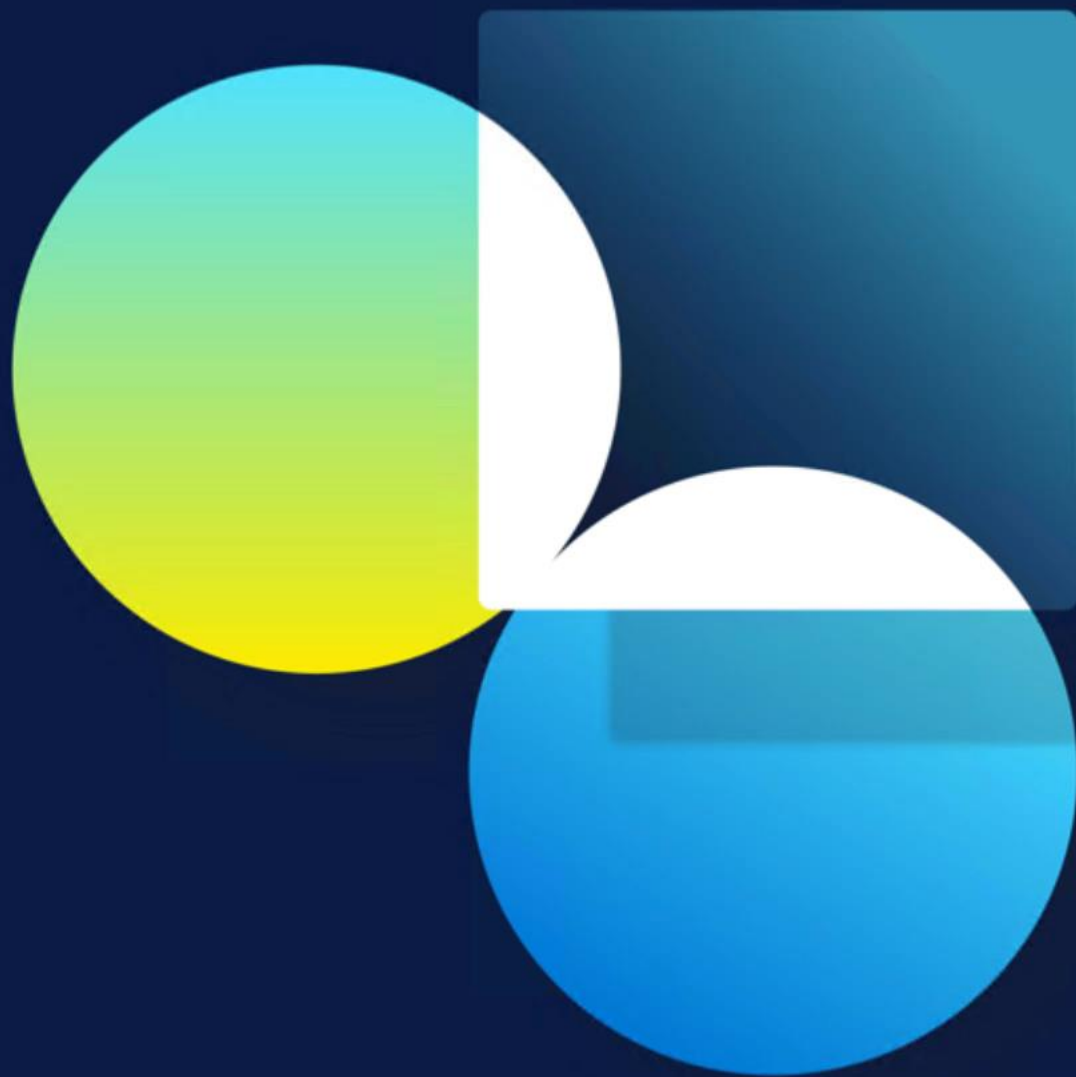

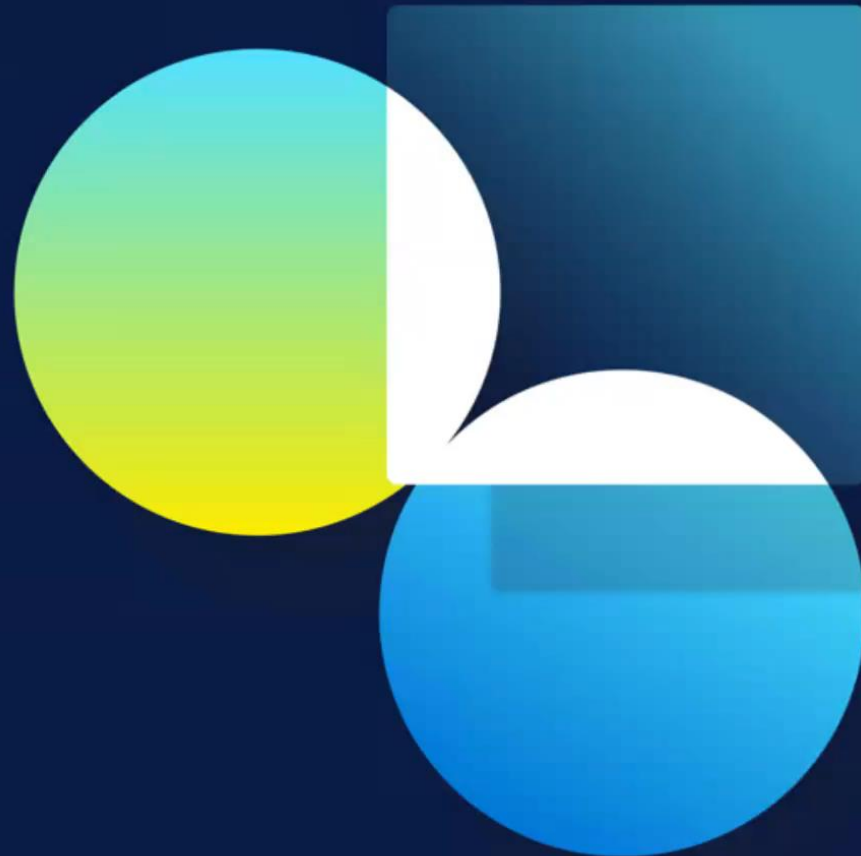
